# **President's Message**

Genealogists, family historians and Genealogy Societies have a legitimate concern over the passing of recent laws concerning access to birth certificates for genealogical purposes. Finding prime source material such as a birth certificate for long passed family members is a cornerstone to genealogical work.

Provided for you this issue is material to make you aware of what is happening and hopefully motivate you to help change our representatives thinking. The following message was received by one of our members after she had written to Congressman Rick Larsen.

Hello Joan,

My name is Mike Dabbs and I am an aide to Congressman Larsen. Congressman Larsen asked me to get back to you on the email you wrote him regarding federal recognition of birth certificates in H.R. 10. As you may know, the 9/11 Recommendations Implementation Act (H.R.10), was never voted on by the Senate after it's passage in the House. Instead it was sent to conference with the Senate's version of the bill, the Intelligence Reform and Terrorism Prevention Act of 2004 (S.2845), which passed both the House and the Senate and became public law on December 17, 2004. Congressman Larsen voted for S.2845 because it provides urgent reforms which are necessary for the safety of our country.

The language in S. 2845 concerning the minimum standards for federal recognition of birth certificates has changed from H.R. 10.

Section. 7211(b)(3) states:

(3) MINIMUM STANDARDS- Not later than 1 year after the date of enactment of this Act, the Secretary of Health and Human Services shall by regulation establish minimum standards for birth certificates for use by Federal agencies for official purposes that--(A) at a minimum, shall require certification of the birth certificate by the State or local government custodian of record that issued the certificate, and shall require the use of safety paper or an alternative, equally secure medium, the seal of the issuing custodian of record, and other features designed to prevent tampering, counterfeiting, or otherwise duplicating the birth certificate

for fraudulent purposes; (B) shall establish requirements for proof and verification of identity as a condition of issuance of a birth certificate, with additional security measures for the issuance of a birth certificate for a person who is not the applicant; (C) shall establish standards for the processing of birth certificate applications to prevent fraud; (D) may not require a single design to which birth certificates issued by all States must conform; and (E) shall accommodate the differences between the States in the manner and form in which birth records are stored and birth certificates are produced from such records.

Congressman Larsen wants you to know that as the Secretary of Health and Human Services works to establish these security measures, he will continue to monitor all developments and certainly keep your views in mind. If I can assist you in any other way, my contact information is listed below.

#### RESTRICTING OUR ACCESS TO RECORDS.

The U.S. House of Representatives is considering a bill, House Resolution 10 (H.R. 10), which seeks to restrict access to birth certificates. David Rencher, chairman of the Record Access and Preservation Committee, a joint committee of the National Genealogical Society and Federation of Genealogical Societies (FGS), has sent a letter to the bill's sponsor, Congressman J. Dennis Hastert, recommending an amendment to the bill that make a distinction between certified and non-certified copies and excludes records more than 100 years old. #### President Signs National Archives Budget

The following is an announcement from the National Archives and Records Administration:

COLLEGE PARK, Md., Dec. 9 -- Congress has passed and the President has approved a budget for the National Archives and Records Administration for Fiscal Year 2005 of \$321,291,000, which exceeds the President's request.

Overall, the budget, slightly greater than last year's appropriation, provides funding to meet the challenges presented by electronic records, address storage and preservation requirements, and improve the National Archives technology infrastructure.

The funds are part of the omnibus spending bill that includes funding for agencies and departments whose regular FY 2005 appropriations bill had not yet been enacted. The measure also authorizes a 3.5 percent pay raise for Federal employees.

Included in the total of \$321,291,000 are \$266,945,000 for operating expenses, \$35,914,000 for the Electronic Records Archives, \$13,432,000 for repairs and restorations, and \$5,000,000 for the National Historical Publications and Records Commission, (NHPRC).

However, the legislation also includes a .83 percent (eighty-three one hundreds of one percent) across-the-board reduction on all accounts. This means an agency-wide reduction of approximately \$2,426,000 from the appropriated amounts.

In commenting on the budget, Archivist of the United States John W. Carlin said, "In this very tight budget climate, the President and the Congress again have demonstrated their support for this agency and the programs and services we provide that are so important to our nation."

Last year, the National Archives received an appropriation of \$316,322,000, with an across-the-board reduction of approximately \$1,866,000.

The new legislation allocates \$266,945,000 for base operating expenses, the level the President requested. It restores a cut the House had made in this account during its consideration of the Archives funding requests.

To meet electronic records challenges, Congress included the Archives request for \$35,914,000 for the Electronic Records Archives, to manage, preserve, and provide access to the Government's electronic records. This is the full amount requested by the President. It is earmarked for the first phase of the system.

To meet storage and preservation needs at our facilities nationwide, the lawmakers approved \$13,432,000 for the repairs and restoration appropriation, which included several items not in the President's request:

\$3,000,000 for site preparation and construction management

I want to take this opportunity to remind you of a long-standing service of the Allen County Public Library. For many decades, individuals who have not had a desire to officially publish their genealogical work have sent an unbound "master copy" to the Historical Genealogy Department. In exchange for the privilege of allowing us to make one photocopy for our collection, we provide the compiler of the work with one complementary bound photocopy in addition to returning the original master.

This is a great way to make sure your work is preserved and available for future generations of researchers. Having a copy at our library ensures your work is secure from any disaster like a fire, flood, hurricane or tornado that could befall your personal library.

Haven't we all heard of cases where personal papers were actually thrown away, or burned, by people who were cleaning up after someone died or was placed in a nursing home. I personally have seen items, which should have stayed in the family, including family bibles and family photo albums, mixed up in boxes with other junk at auctions.

for the new regional archives facility in Anchorage, AK, \$2,000,000 for continuing repairs to the plaza at the Johnson Library in Austin, TX,

\$1,000,000 for design work for expansion at the Kennedy Library in Boston, MA \$750,000 for design of a renovation to the Roosevelt Library in Hyde Park, NY, to upgrade the mechanical and electrical systems and to prepare space for a new privately-funded exhibit, \$500,000 for technical assistance for the private Nixon Library in Yorba Linda, CA. Last year's appropriations bill cleared the way for the Nixon Library to become part of our system of Presidential libraries.

Congress also boosted the President's request of \$3,000,000 for the NHPRC, the grant-making arm of the National Archives, to \$5,000,000. In FY 2004, the NHPRC received \$10,000

It is regrettable that the majority of newspapers in Skagit County, Washington State do not allow access to the archives of their publications. Therefore, Skagit Valley Genealogical Society has collected and filed as many obituaries as possible. We accept no accuracy for the content of the newspaper articles or the obituaries...

Obituaries of Skagit County come from multiple sources. This information has been extracted from available weekly newspapers in the smaller communities as well as from the daily editions of the Skagit Valley Herald. Due to name spellings, some obvious errors in dates, etc, and/or typographical errors the Society is not responsible for any errors found in this database. Not all information is available in all obituaries, as some articles may contain only a death or funeral notice. Many of our collection have been donated previous to the organization of the society, and most of these notices do not contain either the newspaper or the date of publication. They have been included here to make the pertinent information available. In some instances, newspaper articles relating to the deaths of individuals have been preserved.

**Some Background:** The obituaries have been collected since 1987 when our society was organized. An initial contest gave us a few early obits but none that were consistent. When Dee Ackerman of the **Whatcom County Gen Society** passed away she had been collecting obits from the Courier Times and the Skagit Argus for many years and some of her files covered the years from 1980-1986, but we have no way of knowing if this is a complete collection as these are both weekly papers and the majority of obits are published in the Skagit Valley Herald. Then a few years ago, Barbara Harris and her nephew Kenneth Klaus donated some papers from the 70's but I am not sure how many or if they are a complete collection of years. We have no way of knowing for certain on this. Mollie Sackman, John and Shirlee Fisher and others in the society have been in charge of clipping obituaries from local papers since the society was formed. Barbara Ricketts and Norma Keefe-Hills are presently doing that job. The clippings were filed and the Obituary Name Index File was put together in Excel format by Hazel Rasar. Barbara and Norma continue this work.



I haven't come up with the fancy search engine (vet) to make it easier to find the name you are looking for. But I will point out that you can use your web browsers **Search and/or Find** feature by going up to **EDIT**...scroll down to **FIND**...when **the Find what:** box comes up, type in the surname you are looking for...click the **Find Next** button and keep using this button until you find the person you are looking for, (or just scroll down) provided we have their obituary in our files. Obituaries in this index are also in alphabetical order to make it easier to locate your persons of interst. It should be easy to decide as Hazel Rasar put in a lot of work on this file: adding maiden names, birth, age, at death, death dates and whether the individual served in the military. Its very impressive and amazing work. Thank you Hazel.

**Please note:** This current file goes through the end of 1999 and contains 18,000 names. The file will be up-dated shortly through present, courtesy of Hazel, Barbara Ricketts and Norma Keefe-Hills. Also! Depending on how *fast* your computer is and if you are using the 'ol phone lines or the faster DSL, cable modem, etc. The file could take a while to download, please be patient. If you are having any problems, please contact the webmaster, who would be glad to look up a name for you.
