

Legacy User Group: Mary Buzzell is leading a Legacy User Group on the first and third Tuesdays of each month from 1 to 3 PM at the Stillaguamish Library in Arlington. Anyone interested in learning about using a genealogical computer program is invited to attend. While the focus is on the Legacy Family Tree program, much of the information is transferable to other brands. Mary has acquired a video training CR program from Millennia, Legacy's producer. The training subjects are: a 12 step Process for using Family Tree; Mastering Events and Chronologies; Ultimate Guide to Sources; and Tagging and Searching Made Easy. Mary visited with the Legacy folks who had a display7 at the Washington State Genealogy Society Annual Meeting last May in Mount Vernon. They offered to post our sessions on their website and assist us in any way they can.

#### BYLAWS SKAGIT VALLEY GENEALOGICAL SOCIETY

### **ARTICLE III – MEMBERSHIP AND DUES**

#### Section B. Categories of Membership

**3.** Associate. (Delete)

#### Section C. Dues

- **1.** Annual dues for each category of membership shall be determined by the Board of Directors, and approved by a vote of the membership. (Delete) after a 30 day mailed notification of same;
- 2. (Add) Ballots shall be mailed to all members in September and must be received, by return mail or in person, prior to or at the October Annual Meeting.

### **ARTICLE IV – MEETINGS**

Section A. Regular Meetings

1. the Board of Directors may cancel a meeting (Add) at the request of three or more members.

#### **ARTICLE V – OFFICERS AND ELECTIONS**

Section D.Terms of Office

2. (Add) All officers shall take office at the January Board Meeting.

#### **ARTICLE VII – DUTIES OF OFFICERS**

- Section D. Treasurer shall:
  - 5. (Delete) Act as chair of the Finance and Budget Committee with appointed assistants, Present a budget for approval at the Board Meeting prior to the Annual Meeting and at the Annual Meeting (Add) of the membership.

#### **ARTICLE VIII – STANDING COMMITTEES**

Section A. Standing Committees

- 2 Standing committees shall be Membership, Ways and Means, Archival (Add) Historian, Newsletter, Genealogy, Education, (Add) Publication, Publicity, (Add) Projects, Library and Telephone.
- Section B. Standing Committee Chairs
  - 4 Annual Reports shall be presented (Add) to the President and Secretary at the end of the fiscal year.
  - 5 Are encouraged to request (Add) and utilize additional committee members.

#### Section C. Specific Duties:

#### **3** Archival Historian shall:

- a. Collect and preserve all items of historical interest to, and about, the Society;
- b. Collect and preserve the genealogy, biography and pedigrees of members;
- c. Maintain Surname and Locality card files (Add) located in the Society library;
- d. Maintain a permanent file of Society Newsletters.

#### Section C. Special Committees

- 1. Special Committees shall be appointed by (Add) president and approved by the Board of Directors;
- 2. These include, but are not limited to, Audit, (Add) Bylaws/Standing Rules, FGS Delegate, Sunshine and Nominating Committee.

#### **ARTICLE IX – NOMINATIONS AND ELECTIONS**

Section A. Elections

- 1. Elections shall be held at the Annual Meeting (Add) in October.
- 1. Nominating Committee shall:
  - c. Prepare (Add) and mail a ballot for election (Add) of officers and changes to the bylaws.
  - d. (Add) Shall count all written ballots at the Annual Meeting in October.

#### Section C. Voting

- 1. Individual and family members in good standing may vote in Society elections;
- 2. (Add) All voting shall be by mailed ballot
- 3. (Add) Ballots shall be mailed to all members in good standing in September and must be received prior to the October Annual Meeting.
- 4. (Add) Ballots shall be counted at the Annual Meeting by members of the nominating committee.
  - e. (Delete) Voting shall be by voice, providing there is only one candidate for office;
  - f. (Delete) If more than one candidate is running for any one office, the voting shall be by written ballot;
  - g. (Delete) Majority of members present shall elect.

#### ARTICLE X – DISSOLUTION OF SOCIETY

In the event of the dissolution of the Society, (Delete) all saleable (Add) cash assets and genealogical materials of the society shall be donated to (Delete) shall be converted to cash. The monies of the Society shall be used to purchase genealogical materials for (Add) the genealogical collection of a library, historical society or archives.


